ADOPT-A-STREET GUIDELINES

Participating groups agree to the following guidelines:

- Remove all litter from the street and its right-of-way property, and to remove all unnecessary or obsolete posters/signs attached to utility poles or placed in rights of way.
- Place all filled or partially filled trash bags at one location along the Street under the sign designating the Groups' participation in Adopt-A-Street, for pick-up and disposal by the City or dispose of the collected trash bags themselves.
- Provide advance notice to or notify the Solid Waste Division (880-3795) within 48 hours after completion of the Clean-up so that all filled or partially filled trash bags may be picked up and disposed of by the City.
- Complete a reporting form after each clean-up and to return it to the city within 15 days to:

- Obey and abide by all laws and regulations relating to safety and such terms and conditions that may be required or established by the City or the Keep Beaumont Beautiful Commission.
- No member of the Group will possess or consume alcoholic beverages or any illegal substance during the time the Group is cleaning the Street.
- Provide adequate supervision by one or more adults in the event members of the Group are under 18 years of age.
- Maintain a first-aid kit and adequate drinking water while the Group is cleaning the Street.
- The Group hereby agrees to provide all equipment and tools necessary to carry out their responsibilities under this agreement.

ADOPT-A-STREET PARTICIPATION AGREEMENT

This Participation Agreement (the "Agreement") is entered into on this day by and between the City of Beaumont, Jefferson County, Texas (the "City") and _____ (the "Group") for the purposes and consideration herein stated and in recognition of the need to set aside the perception that clean streets are someone else's responsibility, and that an attractive physical environment can aid in the effort to restore pride and self confidence, and in turn, create a significant benefit to Beaumont's economic development prospects.

The Group agrees to adopt _____ (the "Street").

The Group further agrees to be responsible for keeping gutters, curbs, right-of-way property, sidewalks, utility poles, fences, etc. in and along the Street in a clean and attractive state and free from debris.

The Group further agrees to remove all litter from the street and its right-of-way property, and to remove all unnecessary or obsolete posters/signs attached to utility poles or placed in rights of way ("Clean-up").

The Group further agrees to clean up the street at least four (4) times a year.

The Group further agrees to complete the reporting form attached hereto as Exhibit "A" and incorporated herein after each clean-up and to return it to the City within 15 days of the clean-up at the following address:

The Group further agrees to obey and abide by all laws and regulations relating to safety and such terms and conditions that may be required or established by the City.

The Group further agrees to provide adequate supervision by one or more adults in the event members of the Group are less than 18 years old.

The Group further agrees to place all filled or partially filled trash bags at one location along the Street, preferably under the sign designating the Groups' participation in Adopt-A-Street, for pickup and disposal by the City.

The Group further agrees to provide advance notice to or to notify the Solid Waste Division (880-3795) within 48 hours after completion of the Clean-up so that all filled or partially filled trash bags may be picked up and disposed of by the City.

The Group further agrees that no member of the Group will possess or consume alcoholic beverages or any illegal substance during the time the Group is cleaning the Street.

The Group further agrees that it will maintain a first-aid kit and adequate drinking water while the

Group is cleaning the Street. The Group hereby agrees to provide all equipment and tools necessary to carry out their responsibilities under this agreement.

The City agrees to erect a sign at each end of the street with the Group's name or acronym displayed.

The City further agrees to remove all filled trash bags from the designated area along each street.

Term: The term of this agreement shall be for a period of two (2) years beginning on the date of execution of this Agreement. The Group shall have the right to renew this agreement for a like term upon written notice to the City prior to expiration of this Agreement and upon approval of the renewal by the appropriate authority.

Termination: This agreement may be terminated by any party hereto to upon thirty (30) days written notice to all other parties.

Indemnity: Each of the parties hereto, for its predecessors, successors, assigns, heirs, executors, administrators, and legal representatives, releases and forever discharges the other, and its predecessors, successors, assigns, heirs, executors, administrators, and legal representatives, of and from any and all claims, demands, damages, actions, causes of action, or suits in equity, of whatsoever kind or nature whether heretofore or hereafter accruing or whether now known or not known to the parties, for or because of any matter or thing done, omitted, or suffered to be done by either of such parties prior to and including the date hereof and in any way directly or indirectly arising out of this Participation Agreement and Operation Clean Street and all of the transactions and occurrences above described.
