Terms and Conditions:

- No alcoholic beverages or glass containers
- No parking on any grassed area
- No alterations to the facility during use
- Must pick up trash or fine will be assessed
- Damage to facility will be the renter’s responsibility.
- Facility must be rented and paid in full one week prior to practice date. **

****Rental fees are required at the time of rental application. Facility is not secured until payment is received in full by the City of Beaumont Recreation Division. There are no refunds, except cancellation by the Recreation Division or emergencies created by acts of nature.**
