

**DEFERRED DISPOSITION/PROBATION APPLICATION FORM (Art. 45.051 CCP)**

**NOTICE – READ CAREFULLY BEFORE COMPLETING:** This form may *not* be used by juveniles to apply for deferred disposition. All juveniles, 16 years or younger, *must* appear in open court for all proceedings with a parent or legal guardian. If the offense is traffic related and you hold a commercial driver’s license, you are not eligible to request this option. If the offense is traffic related, you must submit a copy of your current drivers’ license and liability insurance with your application. This request must be received by the Court or postmarked within 10 days of receiving your citation. **Contact the court for the correct bond and special expense fee amount to submit for this option. The amount will be equal to the total “window fine” and court costs for the charge.** If your request is approved, you will receive by mail documentation setting forth the terms of your deferred disposition.

I do hereby enter my plea of **No Contest**, waive my right to a jury trial and request Deferred Disposition (Probation) for the Class C Misdemeanor offense of: \_\_\_\_\_. I understand that I must make this request on or before my appearance date and I must meet all the eligibility requirements in order for this request to be granted by the Court. I understand that Deferred Disposition is a privilege, not a right, offered at the sole discretion of the Court.

**I swear the following statements are true and correct:**

1. I am the defendant in the above numbered citation.
2. I hereby enter a plea of “No Contest” and waive my right to a jury trial.
3. I was not charged with exceeding the posted speed limit in excess of 24 mph, operating a motor vehicle without financial responsibility (if an accident was involved), subsequent violation of the financial responsibility law, subsequent violation involving alcohol, and I do not hold a commercial driver license.
4. I have not been on Deferred Disposition for dismissal of an offense within one (1) year prior to the offense date in this matter.
5. I am not currently on Deferred Disposition for another offense in any court.

**6. I have contacted the Court for the correct amount to submit for this option AND am enclosing FULL PAYMENT for this request. PAYMENTS CANNOT BE MADE ONLINE FOR DEFERRED REQUESTS. I understand that a request submitted without full payment will not be approved.**

7. IF the Court grants this request, I understand that I will be placed on probation for a period of time not to exceed 180 days.

8. IF the Court grants this request, I understand that the Court will require that I not be issued a citation for any similar offense during my probationary period.

9. IF the Court grants this request, I understand that the Court may impose additional requirements as it deems appropriate during my probationary period (i.e. attend classes, perform community service, submit to counseling, provide documentation, etc.) and, if ordered to do so, I understand that documented proof of the requirements being met must be filed with the Court in accordance with the terms and conditions set forth in the Order of the Court.

10. IF the Court grants this request, if I have successfully complied with my probation, the Court will process this matter for DISMISSAL BY DEFERRED, and a CONVICTION WILL NOT BE REPORTED.

11. And finally, IF the Court grants this request, and I FAIL TO COMPLY with all the terms and conditions of my probation, I understand that I will have a conviction in this matter and the offense will be reported as required by law.
